DIRECTIONS:

FROM ROUTE 58: TAKE OSBORNE AVENUE NORTH APPROXIMATELY 2.5 MILES, JUST PAST MOBILE HOME PARK, MAKE LEFT ONTO YOUNGS AVENUE

FROM SOUND AVENUE: TAKE OSBORNE AVENUE SOUTH APPROXIMATELY 1 MILE, MAKE RIGHT ONTO YOUNGS AVENUE

HOURS OF OPERATION: OPEN (5) DAYS A WEEK, THURSDAY THROUGH MONDAY, FROM 7:00 AM TO 3:30 PM - EXCEPT HOLIDAYS OR EXTREME INCLEMENT WEATHER. PLEASE NOTE HOLIDAYS LISTED ON BACK OF FLYER.

ALL LOOSE YARD WASTE, INCLUDING GRASS CLIPPINGS, WILL BE ACCEPTED.

YARD WASTE MUST BE LOOSE AND DUMPED BY THE HOMEOWNER. NO BAGGED DEBRIS WILL BE ACCEPTED.

STICKERS MAY BE PURCHASED BY **RESIDENTS ONLY** AT RIVERHEAD TOWN HALL IN THE TAX RECEIVER'S OFFICE. TOWN HALL OFFICE HOURS ARE 8:30AM TO 4:30 PM. THE FEE FOR A YEARLY PERMIT IS \$50.00. A ONE-DAY PASS IS \$15.00. RESIDENTS MAY DROP OFF **LEAVES ONLY**, FREE OF CHARGE, YEAR ROUND WITH PROOF OF RESIDENCY. YOU **MUST** BRING THE CURRENT REGISTRATION FOR THE VEHICLE YOU WILL BE USING IN ORDER TO PURCHASE A PERMIT OR OBTAIN A ONE DAY PASS. DUMP BODY VEHICLES ARE NOT ELIGIBLE FOR A PERMIT.

MULCH IS AVAILABLE, FREE OF CHARGE, WITH PROOF OF RESIDENCY
