PLEASE READ THE FOLLOWING CONDITIONS CAREFULLY BEFORE AGREEING TO BE A MEMBER OF RIVERHEAD YOUTH COURT:

1. Each prospective member of Youth Court must make a one (1) year commitment to fulfilling the responsibilities of membership.
2. Training will be held each Wednesday evening from 6:00 pm to 7:15 pm at the Riverhead Town Justice Court in the Riverhead Police Dept. (Unless otherwise noted)
3. Attendance at all training sessions is mandatory.
4. It is the responsibility of each individual member to receive the necessary written materials when assigned a case and to prepare for your assigned court session during the week prior to the trial.
5. It is the responsibility of each individual member to check their E-Mail regularly for up-to-date information regarding cases and class rescheduling, etc.
6. It is the responsibility of each individual member to bring the training manual, a pen and paper to each session.
7. In order to get credit for the current year of participating in Youth Court, you must attend at least 75% of the Wednesday night meetings.
8. Once you have arrived at a Youth Court session and have signed in, you are not permitted to leave earlier than 7:15 pm unless granted permission ahead of time.
