**AWARDS BID – PROCESS CONTROL SYSTEM MAINTENANCE AND EMERGENCY SERVICES RIVERHEAD WATER DISTRICT PROJECT NO. RDWD2003 (PCS)**

**WHEREAS**, this Town Board did authorize the advertisement for bids for Process Control System Maintenance and Emergency Services for the Riverhead Water District, and

**WHEREAS**, all bids received were opened and read aloud on the date and time advertised in the notice, and

**WHEREAS**, H2M Group, consulting engineers to the Riverhead Water District, by attached letter dated December 16, 2020 did recommend that the bid be awarded to Wire to Water, Inc. for the total bid amount of \$24,930.00 for the period of January 1, 2021 through December 31, 2021.

**NOW, THEREFORE, BE IT RESOLVED**, that the bid for Process Control System Maintenance and Emergency Services for the Riverhead Water District and is hereby awarded to:

In the total bid amount of \$24,930.00 for period  
January 1, 2021 through December 31, 2021

**BE IT FURTHER RESOLVED**, that the Town Clerk forward a certified copy of this resolution to the above-named contractor, and

**BE IT FURTHER RESOLVED**, that the Town Clerk is hereby authorized to return to all unsuccessful bidders their respective bid security, and

**BE IT FURTHER RESOLVED**, that pursuant to this bid award, the Town Supervisor be and is hereby authorized to execute a contract with Wire to Water, Inc. and

**BE IT FURTHER RESOLVED**, that upon completion of fully executed contracts and the filing of said contract with the Town Clerk, the Town Clerk is hereby authorized to release to the successful bidder the bidder's bid security, and be it further
