Teresa, after careful review of the bid results for the George Young Community Center Cupola restoration it is our recommendation that the bids be rejected at this time and rebid in the spring of 2022. The bid received were much higher than anticipated and with inevitable change orders due to unknowns in the understructure of the cupola the project would exceed available funds for this project. It is our contention that material costs will go down in the spring and in addition we intend to reanalyze the project specification to see if there are areas where cost could be reduced or alternate created in the hope that the next round of bidding will bring the project in line with available funds. We will begin working on rebid documents immediately. Please prepare a rejection resolution for the next available Town Board meeting. Thank you. Ken
