ADVERTISEMENT FOR SALE OF OBSOLETE/SURPLUS HIGHWAY DEPARTMENT
VEHICLES/EQUIPMENT**

Councilman Beyrodt Jr. offered the following resolution,
which was seconded by Councilman Rothwell

WHEREAS, the Town of Riverhead Highway Department has authority and control over vehicles/equipment purchased pursuant to the provisions of Highway Law 142 § and the Highway Department has deemed certain vehicles/equipment to be no longer useful to the Town of Riverhead Highway Department; and

WHEREAS, the Town of Riverhead Highway Department seeks to declare certain vehicles/equipment (set forth in Exhibit “A” attached hereto and made a part hereof) obsolete/surplus and dispose of by sale; and

WHEREAS, the Town of Riverhead Procurement Policy, which was amended by Resolution #198 adopted by the Town Board on March 15, 2011, to add Guidelines for the disposal of personal property; and

WHEREAS, pursuant to Guideline 8 of the Town’s Procurement Policy the Town is authorized to dispose of surplus/obsolete property based upon an evaluation by the Town Financial Administrator, with the assistance of the department head, regarding estimated surplus value and, thereafter, recommendation of Financial Administrator to the Town Board regarding disposal or sale; and

WHEREAS, the Highway Department Superintendent and the Financial Administrator agree that the vehicles/equipment be deemed obsolete and the Highway Department offer certain vehicles/equipment for sale “As IS” by competitive bid.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby authorizes the sale of obsolete/surplus Highway Department vehicles/equipment; and be it further



RESOLVED, that the Town Clerk is hereby authorized to publish and post the attached public notice in the May 12, 2022 issue of the News-Review; and be it further

RESOLVED, that all Town Hall Departments may review and obtain a copy of this resolution from the electronic storage device and, if needed, a certified copy of same may be obtained from the Office of the Town Clerk.
