AWARDS BID FOR EPCAL EMERGENCY ACCESS ROAD PROJECT

Councilman Rothwell offered the following resolution,
which was seconded by Councilman Kern

WHEREAS, by Resolution 2023-174 adopted on March 7, 2023, the Town board authorized the Town Clerk to publish and post a request for proposals for the “EPCAL Emergency Access Road Project”; and

WHEREAS, pursuant to the Notice to Bidders all interested entities seeking to submit a proposal were required to attend a mandatory pre-bid meeting and site inspection on March 29, 2023 and each proposal must comply with the instructions contained therein and required that all proposals be submitted on or before 11:00 a.m. on April 6, 2023; and

WHEREAS, ten (10) responses to the Notice to Bidders were received and opened on April 6, 2023 in the Office of the Town Clerk, 200 Howell Avenue, Riverhead, NY 11901; and

WHEREAS, the review committee consisting of Vincent Gaudiello, P.E., Deputy Town Engineer Ken Testa, and Deputy Town Attorney Annemarie Prudenti did review all ten proposals and performed a comprehensive review and comparison of each of the ten responses to the request for proposals and made recommendation to the Town Board that the bid for EPCAL Emergency Access Road Project be awarded to Suffolk Paving Corporation and that the project proceed as Phase I and Phase II as set forth in bid provision “Time for Commencement of Work”; and

NOW THEREFORE BE IT RESOLVED that the bid for EPCAL Emergency Access Road Project be awarded to the vendor indicated below and the project proceed as Phase I and Phase II identified by separate purchase orders;
