REJECTS BIDS FOR RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICE FOR THE RIVERHEAD REFUSE AND GARBAGE DISTRICT

WHEREAS, Town Board Resolution #2023-251 authorized the Town Clerk to publish and post a Notice to Bidders for sealed bids for **RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICE FOR THE RIVERHEAD REFUSE AND GARBAGE DISTRICT**; and

WHEREAS, three (3) bids were received, opened and read aloud on **May 11, 2023 at 11:00 am**; and

WHEREAS, the bids were reviewed and a bid tabulation was prepared by the Purchasing Agent and presented to the Town Board for review; and

WHEREAS, upon review of said bids and consideration by the Town Board, it was found that the bids submitted were not in the best interest of the Town of Riverhead.

NOW THEREFORE BE IT RESOLVED, that the Town Board hereby rejects all bids responsive to the Town's bid for the **RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICE FOR THE RIVERHEAD REFUSE AND GARBAGE DISTRICT**; and be it further
