AWARDS BID - INSTALLATION OF WATER MAINS AND APPURTENANCES SEA CREST ESTATES SUBDIVISION (A/K/A THE VILLAS AT ROANOKE) RIVERHEAD WATER DISTRICT

WHEREAS, H2M Group, consulting engineers to the Riverhead Water District, by attached letter dated January 8, 2024 did recommend that the bid be awarded to Roadwork Construction Corp, the lowest responsible bidder, for the total bid amount of \$252,954.00.

BE IT FURTHER RESOLVED, that pursuant to this bid award, the Town Supervisor be and is hereby authorized to execute a contract with Roadwork Construction Corp., and


