

Dear Board Members:

On Thursday, December 7, 2022, on behalf of the Riverhead Water District (District) bids were received by the Town for the Annual Distribution System Maintenance & Emergency Services contract. This contract included services as described for the 2024 calendar year with a District option to extend the contract for two additional years. Five bids were received with the lowest responsible bid, based on the unit prices included in the bid form, was submitted by **Excav Services Inc.** of Manorville, New York

A copy of the unit price schedule for each of the three years is attached to this letter for reference. Based on the unit prices submitted, the total bid comparison amount submitted for the first year (January 1, 2024 – December 31, 2024) is \$460,084.00. It should be noted that the bid form submitted by the low bidder included certain miscalculations in estimating their total unit cost. In all cases, the contract stipulates that unit rates govern over calculated cost, therefore the contract shall be awarded based on the sum of all unit prices submitted.

Excav Services Inc. has successfully completed similar maintenance and emergency work for the District in previous years. It is our opinion that Excav Services Inc. is qualified, and their unit prices are fair and reasonable. Therefore, we recommend the contract be awarded to Excav Services Inc. of Manorville, New York for 2024 based on the unit prices submitted. Extension of the contract for additional years, shall be done at District discretion by formal letter.

- I. Crew size shall be based upon the minimum manpower effort necessary to complete the work. The Water District has the right to dictate the size of the crew necessary to complete the work associated with the task order. Should the District deem that the crew size is excessive for the work the Contractor will be notified immediately and shall make no charge to the Owner for the excessive effort.
- II. In the event that a smaller crew is utilized to perform the work requested, the contractor shall offer a credit back to the District with the project invoicing.
- III. In the event that additional crew members are required above and beyond what is called for under Item 2, the contractor shall submit, with prior approval from the District, the cost of these personnel with the project invoicing.
- IV. Additional workers will be paid on an hourly basis with hourly rates not to exceed the following:
 - Crew Foreman: \$130/hour + 4% annual increase
 - Laborer: \$115/hour + 4% annual increase
 - Operating Engineer: \$155/hour + 4% annual increase
 - Driver / Chauffeur: \$130/hour + 4% annual increase

- Straight Time: Monday through Friday, 7:00 AM to 4:30 PM
- Nighttime Differential: 4:30 PM to 7:00 AM
- Overtime Differential: Time in excess of 8 hours daily, Monday through Friday & Weekends
- Holiday Differential: Legal and/or Contract Holidays observed by contractor and/or trade union. A list of holidays observed shall be submitted to the District at the time of bid.
