**REJECTS BIDS FOR RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICE AND AUTHORIZES THE TOWN CLERK TO PUBLISH AND POST NOTICE TO BIDDERS FOR RE-BID FOR RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICE**

Councilman Kern offered the following resolution,  
which was seconded by Councilwoman Merrifield

**WHEREAS**, Town Board Resolution #2024-273 authorized the Town Clerk to publish and post a Notice to Bidders for sealed bids for **RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICE FOR THE RIVERHEAD REFUSE AND GARBAGE DISTRICT**; and

**WHEREAS**, five (5) bids were received, opened and read aloud on **April 25, 2024 at 11:00 am**; and

**WHEREAS**, the bids were reviewed and a bid tabulation was prepared by the Purchasing Agent and presented to the Town Board for review; and

**WHEREAS**, upon review of said bids and consideration by the Town Engineer, Town Attorney, and the Town Purchasing Agent, it was found that the bids submitted were not in the best interest of the Town of Riverhead; and

**WHEREAS**, the Town Purchasing Agent wishes to publish and post a Notice to Bidders for **RE-BID RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICE FOR THE RIVERHEAD REFUSE AND GARBAGE DISTRICT**.

**NOW THEREFORE BE IT RESOLVED**, that the Town Board hereby rejects all bids responsive to the Town's bid for the **RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICE FOR THE RIVERHEAD REFUSE AND GARBAGE DISTRICT**; and be it further
