On Thursday, December 19, 2024, the Riverhead Water District received bids for the referenced project. A total of five (5) bids were submitted for Contract P as indicated on the attached bid tabulation. The low Total Alternate Bid was submitted by **Bensin Contracting, Inc.** of Holtsville, New York.

The Total Alternate Bid submitted was in the amount of **\$1,008,000.00**. The alternate bid includes scope relating to the replacement of the District's control valve and swing check valve for the elevated storage tank at Plant No. 9. This scope is critical for the District to optimize the use of their water storage tanks and is recommended to be awarded.

We have reviewed the information submitted by the low bidder and have found them to be a qualified and responsible contractor. Bensin has successfully completed similar work for various water utilities across Long Island in the past. It is our opinion that Bensin is qualified, and their bid prices are fair and responsible. We recommend the Town award the contract to the lowest responsible bidder, **Bensin Contracting, Inc.** of Holtsville, New York, for the Total Alternate Bid amount of **\$1,008,000.00**.

On Thursday, December 19, 2024, the Riverhead Water District received bids for the referenced project. A total of eight (8) bids were submitted for Contract G as indicated on the attached bid tabulation. The low Total Base Bid was submitted by **LoDuca Associates, Inc.** of Blue Point, New York.

The Total Base Bid submitted was in the amount of **\$1,002,048.00**. H2M completed a cursory call with Chris Young and Christopher Perry of LoDuca, on Tuesday, January 7, 2025. LoDuca discussed their experience, project approach, and financial status to confirm they understood the project scope, schedule, and responsibilities. Additionally, LoDuca confirmed that they and their subcontractors meet all apprenticeship training requirements listed in the specifications.

The Total Alternate Bid amount of \$1,098,632.00 includes the scope related to the recharge basin, driveway, and epoxy flooring. However, the basin and driveway work will now be handled by the Town Highway Department, as confirmed with Michael Zaleski on Tuesday, January 7, 2025. Additionally, the Riverhead Water District has opted to omit the epoxy flooring scope.

We have reviewed the information submitted by the low bidder and have found them to be a qualified and responsible contractor. LoDuca has successfully completed similar projects for water utilities across Long Island in the past. It is our opinion that LoDuca is qualified, and their bid prices are fair and responsible. We recommend the Town award the contract to the lowest responsible bidder, **LoDuca Associates, Inc** of Blue Point, New York, for the Total Base Bid amount of **\$1,002,048.00**.

Upon award of this contract by the Board, we will notify the contractor to obtain the necessary bonds and insurance certificates and coordinate with the District's counsel for signing of the contract. Dear Board Members:

On Thursday, December 19, 2024, the Riverhead Water District received bids for the referenced project. A total of Seven (7) bids were submitted for Contract E as indicated on the attached bid tabulation. The low Total Alternate Bid was submitted by **MRJ Industries, Inc.** of Hampton Bays, New York.

The Total Alternate Bid submitted was in the amount of **\$1,100,116.00**. The alternate bid includes electrical scope relating to the replacement of the District's control valve and swing check valve for the elevated storage tank at Plant No. 9. This scope is critical for the District to optimize the use of their water storage tanks and is recommended to be awarded.

H2M and the District conducted a preliminary call with John Ferguson of MRJ on Tuesday, January 7, 2025. This will be MRJ's first project for the Riverhead Water District. In recent years, MRJ has primarily completed projects for various school districts and municipalities, including work with H2M. MRJ brings over 40 years of experience, including work in water treatment plants. During the call, MRJ also discussed their project approach, and financial status to confirm they understood the project scope, schedule, and responsibilities. MRJ expressed confidence that they have the personnel, knowledge, vendor support, and equipment necessary to successfully complete this project without delay and to the District's satisfaction. MRJ confirmed that they and their subcontractors meet all apprenticeship training requirements listed in the specifications and will provide supporting documentation. H2M also contacted MRJ's project references who all recommended the company, highlighting their ability to complete projects on time, communicate effectively, and demonstrate the necessary experience.

Based on our experience with the low bidder and our evaluation of the project references submitted by the low bidder we have found them to be a responsible contractor and capable of performing the project scope. MRJ has successfully completed similar projects for water utilities in the past and similar work for schools and towns across Long Island. It is our opinion that MRJ is qualified, and their bid prices are fair and responsible. We recommend the Town award the contract to the lowest responsible bidder, **MRJ Industries, Inc** of Hampton Bays, New York, for the Total Alternate Bid amount of **\$1,100,116.00**.

Upon award of this contract by the Board, we will notify the contractor to obtain the necessary bonds and insurance certificates and coordinate with the District's counsel for signing of the contract.
