NOTICE TO PROCEED DATE WILL BE SCHEDULED TO INITIATE ON THE DATE THE PROPERTY OWNER'S DEWATERING CONTRACTOR INITIATES INSTALLATION OF THE DEWATERING SYSTEM PERTAINING TO THIS CONTRACT WORK. 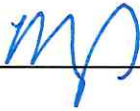

On May 15, 2025, three (3) bids were received for the referenced construction contract rebid. The bid results are as follows:

| 2 | Excav Services Inc. | \$469,060.00 |
| 3 | ADJO Contracting Corp | \$350,000.00 |

We have reviewed the low bid submitted by Bancker Construction Corp. Based on the information provided by the bidder and our experience on past projects with Bancker Construction Corp., we find this contractor to be qualified in performing projects of similar size and complexity to this project. We also find them to be responsible.

Therefore, we recommend that the contract be awarded to Bancker Construction Corp. for THREE HUNDRED FORTY-EIGHT THOUSAND DOLLARS AND ZERO CENTS (\$348,000.00).
