Bidders touring Town facilities will be required to leave a current company business card and a copy of a valid NYS Driver License. Facility tours and inspections of fire and security alarm systems will begin at 4 W. Second Street where copies of required identification and Riverhead Hold Harmless will be taken. Bidders are prohibited from videotaping and/or photographing Town facilities.

Successful vendor shall adhere to all facility rules. A work ticket stating name of technician, date, time of arrival and departure, work performed and parts used shall be completed for each service call and be given the Town Engineer or his authorized representative upon completion of work and prior to leaving the premises.

\*Bidders must submit copy of NYS Alarm License Certificate with license number and expiration date clearly visible at time of bid submission.

\*Bidders must provide proof of manufacturer's certification in Honeywell, Firelite and Silent Night and Radionics alarm systems at time of bid submission.

\*Central Station - Bidder must present complete name of company, company contact person, address, telephone number, fax number for the central station that will be used for this contract at time of bid submission.

The Town reserves the right to add new or additional facility locations to Schedule A and Schedule B under this contract as deemed necessary by the Town Engineer or his authorized representative.

There will be no charge to the Town of Riverhead for updating alarm call out lists and alarm user lists regardless of whether changes are made on-site or remotely. There will be no limit to the amount of times the alarm call out list and alarm user lists can be updated by the Town. Updated lists or any additions or deletions to the existing lists will be performed within 24 hours from the time of the Town request. Town requests will be made in writing and sent via email from the Town Engineer, or his authorized representative. Notification of completed requested changes must be in writing received by the Town Engineering Office within the 24 hour allotted time frame and must be sent via email. Email address will be provided to the successful bidder along with a list of authorized representatives.

There will be no charge to the Town of Riverhead for any programming or equipment upgrades necessary for the successful bidder to assume monitoring of the existing Town facility alarm systems. Any programming changes or equipment upgrades will not be

implemented without the prior written approval of the Town Engineer, or his authorized representative and must conform to all federal, state and local regulations and codes. Any equipment upgrades must be inspected by the Fire Marshal and Town Engineer or his authorized representative prior to acceptance. Replacement alarm system equipment may require a *Town of Riverhead Fire Prevention Permit Application submitted to the Town of Riverhead Fire Marshal*. Any replacements of equipment, devices, etc. will require the testing of all devices in the presence of the Fire Marshal and or Town Engineer or his authorized representative. Any programming changes or equipment upgrades, as approved by the Town Engineer or his authorized representative, will be like in kind and will remain the property of the Town of Riverhead. All operating manuals, programming guides, or any documents needed to install, operate, repair and program or reprogram any replacement alarm systems or apparatus at any Town facility will be given to the Town Engineer or his authorized representative. **THERE WILL BE NO PROPRIETARY LOCKOUTS OR LOCKOUTS OF ANY KIND DURING THE LIFE OF THIS ALARM SYSTEM BY THE INSTALLATION CONTRACTOR AT ANY TIME, FOR ANY REASON.** ACCEPTANCE OF THIS SYSTEM BY THE TOWN ENGINEEROR HIS AUTHORIZED REPRESENTATIVE, TO THE CONTRACTOR WILL REQUIRE THAT THE INSTALLATION CONTRACTOR MUST DEMONSTRATE AND AFFIRM THAT THE OWNER (TOWN OF RIVERHEAD) HAS FULL AND UNRESTRICTED ACCESS TO THIS ENTIRE ALARM SYSTEM INCLUDING BUT NOT LIMITED TO THE CONTROL PANEL, ETC. ACCESS MUST BE UNRESTRICTED FOR ADDITION OF DEVICES, COMPONENTS, DIAGNOSTICS, REPROGRAMMING CHANGES TO ACCOUNT NUMBERS, CENTRAL STATION, PHONE NUMBERS, MONITORING, ETC. IF AT ANY TIME DURING THE USE OF THIS ALARM SYSTEM, THERE OCCURS A LOCKOUT OF TOWN ACCESS BY THE INSTALLATION CONTRACTOR OR HIS REPRESENTATIVE SUCH ACTION WILL RESULT IN THE CONTRACTOR/BIDDER BEING BANNED FROM FURTHER TOWN WORK AND INELIGIBILITY TO OBTAIN FUTURE PERMITS FROM THE TOWN FIRE MARSHAL FOR ANY INSTALLATION WORK WITHIN THE JURISDICTION FO THE TOWN OF RIVERHEAD FIR MARSHAL AND MAY BE SUBJECT TO LEGAL ACTION BY THE TOWN OF RIVERHEAD.

Any new or replacement wiring required must be run in ceilings and walls except for concrete walls as approved by the Town Engineer or his authorized representative. Any new or replacement wiring to be run in ceiling and all cavities where practical. No exposed wiring will be permitted except as approved by the Town Engineer or his authorized representative. Any exposed wiring (as approved by the Town Engineer of his authorized representative) must run in steel conduit to be securely fastened to the wall using two hole steel conduit clamps and lead anchors. The Town of Riverhead may elect to have Town personnel run any new/replacement wiring. Approved accepted wiring to be provided and supplied by the contractor.

Any new or replacement wiring, devices, etc. shall be as per current code.

Any new or replacement "T" bar back boxes shall be provided for all smoke detectors installed in ceiling tiles. No smoke detectors are to be mounted directly to a ceiling tile or ceiling grid track. "T" bars with steel back boxes are required.

Any new or replacement devices including, but not limited to smoke detectors, pull stations, strobes, horn/strobes, key pads, etc. shall be installed using approved steel back boxes. No devices are to be directly wired without use of a steel back box.

Open and Close Supervised Monitoring Reports, for the Town facility locations using this service, must be emailed weekly to the Office of the Town Engineer. Email address will be provided at time of bid award.

Daily testing of alarm communication equipment and communication lines, both primary and secondary lines, is required and will appear on the printed Open and Close Reports where applicable.

There will be no vehicle fuel surcharges of any kind.

Minor repairs and/or minor maintenance may be performed using Town of Riverhead personnel and as directed by the Town Engineer or his representative.

All requests for repairs must be responded to within a two (2) hour time limit. Costs associated with the repair must be conveyed to the Town Engineer or his authorized representative within that two hour time limit so that a purchase order can be obtained and system repairs performed immediately or as soon as possible. Response includes site inspection to determine the problem and repair needed.

All other repairs will be made using the hourly labor rate listed on the Bid Price Sheet plus supplies and materials listed. A cost estimate with a complete list of supplies and materials needed along with any and all associated costs must be supplied to the Town Engineer or his authorized representative prior to the commencement of any repairs. Repairs will require a Town of Riverhead Purchase Order or in the case of any emergency a verbal communication from the Town Engineer or his representative with a Town of Riverhead Emergency Purchase Order number to follow. All repairs will be inspected by the Town Engineer or his authorized representative prior to payment for said services.
