Use the "CHAT" or "RAISE HAND" feature, then use the "CHAT" feature to inform the moderator/host of your NAME and to CONFIRM YOU WISH TO MAKE A COMMENT DURING THE PUBLIC HEARING. If you are calling in, please dial \*9 to "raise your hand", so we can acknowledge your request to speak.

When it is your turn to speak, your status will be temporarily changed so you can be unmuted and visible for the comment period. After the comment period, you will be placed back in the audience.
