Board and the Town Board after the Town Board has concluded with public hearings and resolutions at their respective meetings held on June 2, 2021.

PLEASE TAKE FURTHER NOTICE, that upon entering the Zoom meeting, you will be placed in a virtual audience. From there, you may either passively watch the meeting live, or communicate with the moderator/host your request to make a comment during the public comment section for PUBLIC HEARINGS, RESOLUTIONS and/or OPEN COMMENTS. To get the attention of the moderator/host, use the “CHAT” or “RAISE HAND” feature, then use the “CHAT” feature to inform the moderator/host of the following:

1) Name; 2) Hamlet; 3) Public Hearing, Resolution and/or Open Comment topic.

If you are calling in, please dial *9 to “raise your hand”, so we can acknowledge your request to speak.

When it is your turn to speak, your status will be temporarily changed so you can be unmuted and visible for the five-minute comment period. After five minutes, you will be placed back in the audience.
