**RESCIND AND REPEAL STATE OF EMERGENCY IN THE TOWN OF RIVERHEAD**


**WHEREAS**, I, Yvette M. Aguiar, Supervisor of the Town of Riverhead, pursuant to Article 2-B Section 24 of the New York State Executive Law did declare a State of Emergency in the Town of Riverhead by issuing a State of Emergency/Disaster Emergency Order on March 12, 2020 and effective on March 13, 2020 in response to the public health emergency related to the World Health Crisis and United States Health and Human Services declaration of public health emergency for the entire nation due to COVID-19; and


**WHEREAS**, I, Yvette M. Aguiar, Supervisor of the Town of Riverhead, pursuant to Article 2-B Section 24 of the New York State Executive Law, did amend, modify and issue subsequent local emergency orders related to the COVID-19 public health emergency/crisis with the most recent by State of Emergency/Disaster Emergency Order 2020SOE-92 issued on June 10, 2021 and effective on June 11, 2021 and terminating on June 15, 2021; and

**WHEREAS**, while COVID-19 crisis has diminished, due to the proactive steps and restrictions of Federal, State, County, and Town implemented during the pandemic, the increased availability of vaccinations, the number of individuals vaccinated and the significant and dramatic decline in positivity rates and hospitalizations, I, as Supervisor and Chief Executive Officer of the Town determine that there is no longer a requirement for a local State of Emergency declaration; and

**WHEREAS**, notwithstanding the determination not to renew, extend, or issue a declaration of a local State of Emergency, all or any, Executive Orders issued by the Governor shall remain in full force and effect; and

**NOW THEREFORE**, I, Yvette M. Aguiar, Supervisor and Chief Executive Officer of the Town of Riverhead, pursuant to Section 24 of Article 2-B of the New York State Executive Law, do hereby rescind and repeal, effective immediately, Town of Riverhead Local Emergency Order No. SOE2020-92, which extended a declaration of a State of Emergency in the Town of Riverhead, originally issued on March 12, 2020 and effective on March 13, 2020, and repeal all Town of Riverhead Local Emergency orders.
