RIVERHEAD DECLARED “YELLOW ZONE” MICRO CLUSTER STATUS

The Town of Riverhead has reached “Yellow Zone” status in accordance with the New York State Micro Cluster Strategy program, as declared by the Governor during a press conference held earlier today.

Supervisor Yvette Aguiar stated, “I am urging all Riverhead residents to remain vigilant especially with the holiday season upon us. Now more than ever we need to strictly adhere to the three COVID-19 “W’s:

- WEAR your mask
- WATCH your distance, remain 6 feet apart whenever possible,
- WASH your hands frequently

In an effort to reduce the uptick in positive COVID-19 cases in our area, we have increased outreach to our residents. A robo call was sent out to Riverhead residences in both English and in Spanish. We have been flooding the media, print radio and television, with reminders to be tested. Testing is a crucial element of battling the spread of the virus. I encourage every resident of Riverhead to be tested at one of the following COVID-19 testing sites within our area.”

Yellow Zone designation guidelines are as follows:

- Non-residential gatherings are restricted to 25 people maximum, indoor and outdoor.
- Residential gatherings are limited to 10 people, indoor and outdoor.
- Houses of worship must remain at 50% maximum capacity.
- Indoor dining and outdoor restaurant dining is permitted with a *four person maximum per table*. Restaurants and bars must close at 10 p.m. for on premises consumption *only*.
