** Based on current health metrics, NYS has permitted the following industries in Phase Three to reopen:

- Food Services (including catering, taverns, bars, restaurants with indoor seating/table service)
- Personal Care

IMPORTANT: LICENSED BUSINESSES ACROSS ALL INDUSTRIES MUST COMPLETE PARTS “A” AND “B” PRIOR TO REOPENING!!
