

AUTHORIZES TOWN CLERK TO PUBLISH AND POST NOTICE TO  
BIDDERS FOR RIVERHEAD TOWN-WIDE SOLID WASTE COLLECTION  
AND DISPOSAL SERVICES

COUNCILPERSON PRUSINOWSKI offered the following resolution, which was seconded by COUNCILPERSON STARK

WHEREAS, the Town Board caused to be published a notice to bidders for the solicitation of bids for the Townwide Solid Waste Collection and Disposal Services; and

WHEREAS, contained in said Notice to Bidders, was qualifications defining qualified bidders as those being licensed with the Town of Riverhead as of January 1, 1991, pursuant to Riverhead Town Code;

WHEREAS, said bids were received, opened and read aloud at the Town Clerk's Office on October 31, 1991, at 4:00 p.m., the place, date and time prescribed in the Notice to Bidders; and

WHEREAS, an action was filed against the Town of Riverhead contesting the bidding requirements; and

WHEREAS, the Town Board, on December 31, 1991, adopted Resolution #655 awarding bids for the Townwide Solid Collection and Disposal Services; and

WHEREAS, after the awarding of the bids, the Supreme Court determined that the condition that bidders be licensed on January 1, 1991, may violate the policy underlying Section 103 of General Municipal Law.

NOW, THEREFORE, BE IT

RESOLVED, that the Town Board, in the interest of serving the taxpayers of the Town of Riverhead and in accordance with the Court order made in the aforementioned action, the Town Board of the Town of Riverhead hereby rescinds the awarding of the bids adopted by Resolution #655 on December 31, 1991, and desires to cause to be published and posted a Notice to Bidders for the collection, removal and disposal of solid waste from residential dwelling units.

RESOLVED, that the Town Clerk be and is hereby authorized to publish and post the attached notice to bidders for the collection, removal and disposal of solid waste from residential dwelling units in the JANUARY 22, 1992 issue of the Suffolk County Life and in three (3) consecutive issues of Newsday.

**TOWN OF RIVERHEAD  
NOTICE TO BIDDERS**

**RESIDENTIAL SOLID WASTE COLLECTION AND DISPOSAL SERVICES  
Riverhead Townwide Solid Waste Collection District  
April 1, 1992 through December 31, 1996**

Sealed bids will be received until 4:00 p.m. on February 13, 1992, by the Town Clerk, 200 Howell Avenue, Riverhead, New York, 11901, for the collection, removal and disposal of solid waste from residential dwelling units in each of six (6) Contract Bid Areas for April 1, 1992, through December 31, 1992, and the years of 1993, 1994, 1995 and 1996. Immediately upon receipt of the bids, they will be publicly opened and read aloud in the Office of the Town Clerk.

Bid packages may be obtained on or after January 22, 1992, at the Town Clerk's Office between the hours of 9:00 a.m. and 4:30 p.m. Monday through Friday upon payment of fifty dollars (\$50.00) in cash or certified check made payable to the "Town of Riverhead" for each package requested.

Each bid must be submitted on the forms furnished by the Town of Riverhead with the bid package. Each envelope containing a bid must be sealed and must clearly show the name and address of the bidder and the letter designation of the Contract Bid Area to which the bid applies and must state:

**Bid for Residential Solid Waste Collection  
and Disposal Services**

Each bid must be accompanied by a certified check or bond on the enclosed bid bond form in a sum not less than five percent (5%) of the bid price for 1992 and payable to the "Town of Riverhead". Failure or refusal to execute the Contract and deliver the required performance security and insurance certificates, within thirty (30) days after award of contract may, at the Town's option, result in forfeiture of the check or bid bond as a liquidated damage or other action as may be deemed in the Town's best interest.

A separate bid must be submitted for each Contract Bid Area within the Riverhead Townwide Solid Waste Collection District. The bid package will be annexed to and made part of the executed Contract.

The Town of Riverhead reserves the right to reject any or all bids, to waive irregularities and/or informalities in any bid, and to make an award in any manner consistent with law, deemed in the best interest of the Town.
