





RESOLUTION NO. 293     AUTHORIZES TERRY CONTRACTING & MATERIALS  
INC. TO PERFORM REPAIRS ON EAST CREEK  
DOCKING FACILITY BULKHEADING ON AN  
EMERGENCY BASIS

Councilwoman Blass offered the resolution, which was seconded by Councilman Bartunek.

The Vote, Dunleavy, yes, Bartunek, yes, Blass, yes, Densieski, "I didn't support the town running the East Creek Marina, but the Town Board majority voted for it and I respect that. This is an emergency repair to a town owned facility; so I feel obligated to vote yes. I'm concerned about the fact that the Department of Recreation has not been notified, but Barbara is going to notify them. I am questioning the wisdom of government running a marina, but I've come to peace with that, and am going to support this, and I'm going to vote, yes."

Supervisor Cardinale, "I'm going to vote yes, because it's an emergency situation and after this season, we'll definitely take a hard look whether this should continue running a marina or not."

The resolution was thereupon declared to be duly ADOPTED.
