Minutes of a joint meeting of the Town Board and  
Town Superintendent of Highways of the Town of Riverhead  
held in the Town Hall Friday, Nov. 5, 1909 at 1 o'clock p. m.

Supervisor Homan submitted his Highway Report for  
the past year and on motion same was approved.

The following estimate was made as to the amount of  
money the town is to raise for highway purposes for the year  
1910.

For the repair and improvement of town highways  
including culverts, sluices, and bridges having a span of  
less than five feet, \$14,500

For the repair and construction of the bridge on the  
Peconic Bay Boulevard crossing the stream between the property  
of Milner Wells and Victor Wilson, 300

For the general repair of all bridges having a span  
of more than five feet and not included in above, 200

For the purchase of machinery, tools, etc., 500

For removal of obstructions caused by snow, cutting  
weeds and brush, allowance for shade trees, watering troughs,  
and other misscelaenous purposes, 500

Resolved, That the estimate made by the town Board  
and Town Supt. of Highways of \$14,500<sup>0</sup> be the amount of the  
First Item in said estimate.

Resolved, That the estimate made by the Town Supt.  
and approved by the Town Board of \$15,00 be the amount of  
Items, Two, Three, Four and Five in said estimate.

On motion the Town Clerk was instructed to have the  
Highway Report of the Supervisor published in the local  
papers at an expense not to exceed \$10.

On motion the following resolutions were adopted:

Resolved, That the Supervisor be instructed to inset  
in the Tax Levy the sum of \$16,000 for highway purposes.

Resolved, That the Supervisor be instructed to inset  
in the Tax Levy the sum of \$2,500 for expense of laying out  
a new highway at Wading River, allication of H. B. Howell.

Resolved, That the Supervisor be instructed to inset  
in the Tax Levy the sum of \$1,000 for Town Supterintend's  
services.

Resolved, That the Supervisor be instructed to insert  
in the Tax Levy the sum of \$1,250 for Fire Dept. purposes.

Resolved, That the Supervisor be instructed to

insert in the Tax Levy the sum of \$1,000 for lighting the Riverhead Lighting District.

Resolved, That the Supervisor be instructed to insert in the Tax Levy the sum of \$4,000 for Contingent Fund.

On motion the Supervisor was allowed the sum of \$125 per annum for his services under section 110 of the Highway Law.

On motion the Town Clerk was allowed the sum of \$25 per annum for his services under section 110 of the Highway Law.

There being no further business meeting adjourned.
