The minutes of the meeting of the Town Board held on May 24,1933 were read and on motion and vote duly adopted.

A communication was read from Mrs. Walter F. Barnes, requesting that "The Howell M. Reeve Park " be always designated by that name and requesting that a suitable sign be erected at the entrance to the Park with the name "The Howell M. Reeve Park" inscribed thereon.

On motion by Justice Burnside, seconded by Justice Stackpole and duly carried it was Resolved that the communication from Mrs. Walter F. Barnes be referred to the Highway Committee with power to have an entrance constructed with the name "The Howell M. Reeve Park " suitably inscribed thereon and be it further Resolved That the Town Clerk be instructed to write Mrs. Barnes advising her of the action of the Town Board in this matter.

The Highway Committee reporting on the Petition to lay out a highway extending from East Main Street to Riverside Drive, a continuation of River Avenue, advised that Mrs. E. H. Howell had not as yet been seen for the purpose of ascertaining if she would dedicate the necessary land.

On motion duly made by Justice Rubenstein, and seconded by Justice Burnside, it was Resolved That the land dedicated by property owners for a highway to extend from East Main Street to Riverside Drive, be and the same hereby is accepted by this Board and be it further Resolved That Justice Stackpole be authorized to try to secure the dedication of land by the Estate of E.H. Howell and that the

Superintendent of Highways be and he hereby is instructed to proceed with the construction of the highway as requested by the petitioners and that condemnation proceedings be instituted, if necessary, to complete the laying out of the highway.
