RESOLUTIONS

#319 RATIFIES ACTION OF TOWN ATTORNEY AND SPECIAL COUNSEL IN BRINGING AN INJUNCTION AGAINST WORLD LIFE ENTERTAINMENT, THE OWNERS OF THE RIVERHEAD RACEWAY

Councilman Lombardi offered the following resolution, which was seconded by Councilman Artale.

RESOLUTIONS Continued:

WHEREAS, the Town Board had been advised as of April 17, 1985 that building construction without a building permit and other building violations may exist at the Riverhead Raceway property owned by World Life Entertainment, and

WHEREAS, the Town Attorney has discussed this matter with the Town Board and the Town Board desires to bring legal proceedings to enjoin the operation of the Riverhead Raceway until all building violations have been remedied, and

WHEREAS, the Town Attorney has commenced such legal proceedings in accordance with the Town Board.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board ratifies the action of the Town Attorney and special counsel; Priscilla Corkrey of the office of Peter S. Danowski, Attorney at Law, in bringing an injunction against World Life Entertainment, the owners of the Riverhead Raceway, for the purpose of enjoining the operation of such Raceway until all building violations have been eliminated at the Raceway premises.

There being no further business on motion and vote, the meeting adjourned at 3:34 P.M.
