**AUTHORIZES TERRY CONTRACTING & MATERIALS INC. TO PERFORM REPAIRS ON EAST CREEK DOCKING FACILITY ON AN EMERGENCY BASIS**

**COUNCILWOMAN BLASS**

\_\_\_\_\_ offered the following resolution which was seconded by COUNCILMAN BARTUNEK.

**WHEREAS**, on or about February 2006, the bulkhead located on the east side of the East Creek Docking Facility collapsed, creating a danger to the general public; and

**WHEREAS**, an immediate repair of the aforementioned bulkhead is necessary and will be completed by Terry Contracting & Materials, Inc; and

**WHEREAS**, pursuant to General Municipal Law §103(2)(4) when a public emergency arising out of an accident or other unforeseen occurrence which requires immediate action which can not await competitive bidding contracts for work may be let by the appropriate board.

**NOW, THEREFORE, BE IT RESOLVED**, that Terry Contracting & Materials, Inc. is authorized to execute the work necessary to repair the collapsed bulkhead at the East Creek Docking Facility; and

**BE IT FURTHER RESOLVED**, that the Riverhead Town Board be and does hereby approve the payment to Terry Contracting & Materials, Inc. for the work required, not to exceed the sum of \$172,695.00 to be reimbursed from Park and Recreation Funds.

**BE IT FURTHER RESOLVED**, that the Riverhead Town Board hereby authorizes the Supervisor to execute the voucher for payment; and

**BE IT FURTHER RESOLVED**, that the Town Clerk be and is hereby authorized to forward a certified copy of this resolution to Terry Contracting & Materials, Inc., Kenneth Testa P.E., Office of the town Attorney and Office of the Accounting.
