710 Appoints 30 Day Clerk Typist position to the Recreation Department

711 OPPOSES LOCATION OF METHADONE CLINIC AT EDWARDS AVENUE

COUNCILPERSON _____ offered the following resolution, which was seconded by COUNCILPERSON _____:

WHEREAS, the County of Suffolk has proposed locating a substance abuse clinic, known as The East End Methadone Clinic, on Edwards Avenue, Calverton, Town of Riverhead, New York; and

WHEREAS, the Town of Riverhead currently supports its fair share of Suffolk County services, wherein the burden of such services to the Town of Riverhead outweighs the benefit to the residents of the Town of Riverhead; and

WHEREAS, the Town Board of the Town of Riverhead strongly opposes locating the East End Methadone Clinic at Edwards Avenue, Calverton, New York; and

WHEREAS, the proposed location of said clinic on Edwards Avenue in the primary Industrial Corridor of the Town of Riverhead is not an appropriate location and would be considered poor planning in view of the industrial nature of the zoning district criteria; and

WHEREAS, the placement of a methadone clinic in a contractors' building in an industrially-zoned area is clearly not the highest and best use of prime industrial land in the Town of Riverhead; and

WHEREAS, the location at Edwards Avenue, Calverton, New York, is not served by means of a public transportation system which would make the placement of the clinic at this location neither viable nor feasible and thereby limiting the use of the clinic to those with their own means of transportation; and

WHEREAS, pursuant to Mental Hygiene Law, and its accompanying regulations, the intent and goal in locating a substance abuse clinic should be that the substance abuse clients should receive treatment, and other services, in the community within which they live, and that the proposed clinic would be best located in the municipality where a majority of its clients reside and at a location which can accommodate their needs.

NOW, THEREFORE, BE IT

RESOLVED, that the Town Board of the Town of Riverhead hereby strenuously opposes the placement of the East End Methadone Clinic on Edwards Avenue, Calverton, Town of Riverhead, New York; and be it further

RESOLVED, that the Town Clerk be directed to forward a certified copy of this resolution to the Suffolk County Legislature; Commissioner Cavalarro; Legislator Michael Carriccialo; and Suffolk County Executive Patrick Halpin.
