PLEASE READ THE FOLLOWING CONDITIONS CAREFULLY BEFORE AGREEING TO BE A MEMBER OF RIVERHEAD YOUTH COURT:

- 1. EACH CASE BOUGHT TO TRIAL AT RIVERHEAD YOUTH COURT IS AN ACTUAL CASE WHERE CHARGES HAVE BEEN BOUGHT AGAINST THE RESPONDENT. AT ANYTIME IF A MEMBER IS UNCOMFORTABLE TAKING PART AS A PARTICIPANT OR AN OBSERVER, THEY MAY BE EXCUSED UPON THEIR REQUEST TO YOUTH COURT PERSONNEL.**
- 2. Each prospective member of Youth Court must make a one (1) year commitment to fulfilling the responsibilities of membership.**
- 3. Each prospective member MUST submit a completed Youth Court Membership Application by October 12, 2021.**
- 4. Training will be held each Tuesday evening from 6:00 pm to 7:15 pm at the Riverhead Town Justice Court in the Riverhead Police Dept. (Unless otherwise noted)**
- 5. It is the responsibility of each individual member to check their E-Mail regularly for up-to-date information regarding cases and Youth Court class rescheduling, etc.**
- 6. In order to get credit for the current year as a participant in Youth Court, you must *not be absent for more than 4 sessions*. An excused absence will be accepted with an email to the YC Coordinator or Secretary by 4PM on the afternoon of meeting date. This will ensure that you continue to be considered an active member of the Youth Court Program.**
- 7. Once you have arrived at a Youth Court session and have signed in, you are not permitted to leave earlier than 7:15 pm unless granted permission ahead of time.**
