WHEREAS, the Town Purchasing Agent has requested that the contract with the above mention vendor be extended for one (1) year beginning August 15, 2018; and

WHEREAS, United Metro has agreed to extend the contract price until August 15, 2019 for the original price, terms and conditions set forth in the original contract.
