AWARDS BIDS FOR TOWN OF RIVERHEAD SALE OF OBSOLETE/SURPLUS HIGHWAY DEPARTMENT VEHICLES/EQUIPMENT "AS IS" CONDITION

Councilwoman Kent offered the following resolution,

WHEREAS, the Town Board, by Resolution #204 adopted on March 19, 2019, authorized the Town Clerk to publish and post a notice to bidders for sealed bids for SALE OF OBSOLETE/SURPLUS HIGHWAY DEPARTMENT VEHICLES/EQUIPMENT "AS IS" CONDITION (twelve obsolete/surplus items were offered for sale); and

WHEREAS, the Town received bids from three (3) bidders (Fabtex, Michael Majsce; and Steven Zanazzi) at the date, time and place given in the Notice to Bidders, to wit: 16th day of April, 2019 at 11:00 a.m. at Town Hall, 200 Howell Avenue, Riverhead, New York; and

WHEREAS, Fabtex submitted a bid for Item Three (International Tractor (HWY23) V#2230153B100534X) and, shortly after bid opening, notified the Highway Department and sent letter to the Town Clerk expressing Fabtex's desire to withdraw its bid; and

WHEREAS, the Highway Superintendent recommends that the Town accept Fabtex request to withdraw its bid and award Item Three to the second highest bidder, Steven Zanazzi; and
