WHEREAS, the Town Clerk was authorized to publish and post a notice for sealed bids for **2017 OR NEWER FIRST RESPONDER VEHICLE** for the Town of Riverhead and;

WHEREAS, three bids were received, opened and read aloud in the Office of the Town Clerk, 200 Howell Avenue, Riverhead, NY 11901 on AUGUST 1, 2018 at 2:00 pm; and

WHEREAS, the Purchasing Agent reviewed all bids and prepared a tabulation for consideration by the Town Board; and

WHEREAS, the Purchasing Agent, after review of the specifications has determined that **Eagle Chevrolet** is the lowest responsible bidder; and

WHEREAS, based upon the above, the Purchasing Agent recommends that the bid be awarded to **Eagle Chevrolet** for **\$58,200.00**; and

NOW THEREFORE BE IT RESOLVED, that the Town Board accepts the recommendation of the Purchasing Agent and awards the bid for a **2019 CHEVROLET TAHOE** fully equipped; and
